REMINDERS TO RESIDENTS

MOVING - If you are selling your house and moving out of Summerlakes, you need to notify the Clubhouse at least two weeks prior to closing to get your closing letter and packet. You will not be able to close without it. There is a \$100. fee for this process.

RENTING - If you are renting out your home in Summerlakes, please notify the Clubhouse staff of who your tenants are, and keep us updated when changes are made. Tenants are required to show a copy of the rental lease in order to obtain Clubhouse privileges.

COMPLAINTS - When reporting a homeowner complaint or concern, please be courteous and include your name with your notes or phone calls so we can address these issues with you. Most concerns have a simple explanation, but how can we let you know if we don't know *who* you are!

PARKING - Please note that the Clubhouse parking lot is private property, and is not to be used as a meeting place or personal parking space. Any cars using the parking lot other than for visiting the facility, or cars left in the lot after the 9:00 p.m. closing time will be subject to being towed. Residential parking is available on both sides of Continental Drive.

ASSESSMENTS - When assessment payments are behind, it is the policy of the Clubhouse to hold ID cards and suspend privileges of <u>all</u> family members until payment is brought current.


Motions of Board of Directors Meeting November 12, 2015

WINTER PARKING REGULATIONS & SNOW REMOVAL

As winter is approaching, the following information is provided to residents by the Warrenville Police Department: The City of Warrenville Ordinance 5-3-9 states that no vehicle shall be parked on any street, roadway, or roadway shoulder for a period of 24 hours immediately after the accumulation of two inches (2") or more of snow, or until the street or roadway has been cleared of snow.

Snow removal by the City is done on all main and through streets before clearing begins on side streets, dead ends, or cul-de-sacs.

Summerlakes will resume the snow removal of the northwest sidewalk along Continental Drive from Lakeview Drive to Johnson School, and on the west side of Shaw Drive only, to accommodate children walking to school.

Property owners are encouraged to remove the snow and ice from the sidewalk in front of their homes to accommodate pedestrians.

There are numerous areas throughout the City where the sidewalk is located in front of common property where there are no homes. In these instances, the City encourages the property owners abutting these sections of sidewalk to remove the snow and ice. During the winter months please help firefighters by keeping the fire hydrants free and clear of snow and ice.

MAILBOX DAMAGE

The City's Public Works crews work diligently to remove snow from roadways in a timely manner. Sometimes the snow is so heavy that when it comes off the plow, it can damage free standing mail-boxes.

For reimbursement consideration, claims should be submitted within 30 days of the damage. Download a claim form atwww.warrenville.il.us, select Departments > Public Works > Street Division > Mailbox Replacement. Questions may be directed to the Public Works Department (630) 393-9050.

TIPS FOR PREVENTING FROZEN WATER LINES

Remove garden hose from outside spigot

- Allow warm air to circulate around water meter
- Tightly seal any vents or access areas in crawl space
- If water pipes are on an exterior wall, leave cabinet

doors open for better exposure to heat

- Let water run at a trickle on extremely cold nights (about the diameter of a pencil)
- Contact the Water Department to shut off water on vacant properties
- Low water pressure could be an indicator that pipes are starting to freeze
