### Easy Ways to Increase Your Gas Mileage 1. Go Easy on the Pedal


Speeding, braking, and rapid acceleration waste gas. Depending on the type of vehicle, poor driving habits can negatively affect fuel economy between 15% and 30%. Gas mileage efficiency tends to decrease above 50 miles per hour.

#### 2. Get a Tune Up

The National Institute for Automotive Service Excellence indicates that bad spark plugs can decrease fuel economy by up to 30%. Getting a fuel injection service and cleaning the throttle body at this time can help.

#### 3. Leave Extras at Home

An additional 100 pounds in your car can reduce gas mileage by up to 1%. The reduction is relative to the vehicle's weight. Smaller vehicles are more affected by increased weight than larger ones.

#### SUMMERLAKES HOMEOWNERS' BOARD MEETING MAY 12, 2022

Meeting was called to order by President SteveLewis at 7:02

**Board Members Present:** Steve Lewis; Harlan (Nick) Davis; Fred Baker; Megan Kleiber; Pam Watts; Jeanne Tassotto Absent: Mike Dobosiewicz Also present: Michele Speedy

#### Board Member Comments: None

<u>Secretary Report</u>: April minutes were submitted for approval. Fred Baker moved to approve as read, motion was seconded by Megan Kleiber. Motion passed

**<u>Financial Report</u>**: The April financial report was submitted for approval. Motion to approve was made by Jeanne Tassotto, seconded by Megan Kleiber. Motion passed.

#### Old Business:

**Computer:** Fred Baker reported that the desk top computer needs to be updated in order to link with the laptop. Fred made a motion to spend up to \$1200 on needed hardware and software purchases. Seconded by Jeanne Tassotto. Motion carried.

**Pool:** Steve Lewis reported that he had met with two pool vendors who both had made suggestions on pool designs. These will be presented in more depth later when he receives the written reports.

Fred Baker reported that there is a 11/2" copper pipe that will need to be replaced. This comes under maintenance and repairs.

**Ponds:** Steve Lewis reported that the water is too high and the ground is too wet to do any work or plantings at this point. Once conditions improve work will continue.

Water Treatment at Continental Pond: There is algae at Continental pond that needs to be treated. Pam Watts made a motion to spend up to \$3500 for treatment, Megan Kleiber seconded. Motion carried.

**Playgrounds**: Kirstin Davis has quotes for playground equipment - three options for each playground (Continental and Cynthia). She also has met with Fermilab for a possible grant and will follow up with a written request. Megan Kleiber also has quotes for various options. This committee will meet and have proposals ready to send to homeowners for a final decision.

**Picnic**: The date for the picnic will be July 17th. Megan Kleiber has contacted food truck vendors for sno-cones, hot dogs, tacos and hamburgers. There will be no cost to SHA, just to the purchasers.

#### New Business:

**Rules Update:** Due to an incident of alleged unauthorized filming in Clubhouse restroom/locker room our attorney will be reviewing and updating our Clubhouse rules. These will be sent out to all homeowners in a mass mailing and posted at the Clubhouse.

**Delinquent Accounts:** Accounts over \$300 have been turned over to our attorney for collection. Most have have paid or are on a payment plan, the remainder are being sent demand letters prior to being taken to court. Property seizure has been discussed.

#### Architecture Committee Report:

**Bank Stabilization**: Steve Lewis reported that the bank stabilization is proceeding. He will meet with the City about the refund of the money they are holding pending closure of this project.

**Completed Projects**: Mickie Speedy reported that the AC work has been completed and the electrical problems in the party annex have been resolved.

Motion to adjourn by Fred Baker, seconded by Harlan (Nick) Davis. Motion carried.
